# What to Bring to Eligibility Appointment

- $\Rightarrow$  Proof of HIV (copy of official laboratory test)
- $\Rightarrow$  Proof of Florida residency (i.e. photo ID)
- ⇒ Proof of Insurance (if applicable) If you are employed, we need proof that no insurance is offered to you on company letterhead signed by a supervisor.
- ⇒ Proof of Income (last 3 paystubs, social security award letter, last completed IRS tax return, unemployment paystubs)

# What to bring to ADAP Enrollment Appointment

- You must first complete steps one and two as shown on opposite page if you have not already done so.
- Please ask your Ryan White Case Manager to fax a copy of your Notice of Eligibility to the ADAP office or bring a copy with you.
- If you have insurance, we need a copy of the policy details including information about the prescription coverage. If the cost of the insurance is not affordable, we need proof of the cost.
- If you have Medicare, <u>you must obtain Medicare Part D and apply for Low In-</u> <u>come Subsidy (LIS)</u>. Bring documentation of award or denial with you.
- If potentially eligible, you must apply for Medicaid, we will need documentation of application denial.
- Please bring your State of Florida issued picture ID, and Social Security Card.
- CD4 and Viral Load results less than six months old.
- Current prescription(s) that are on the ADAP formulary. We must have an original prescription not faxed or copy.
